

SCI IEQCC Summit HIGHLIGHTS DAY 1

On September 23, members of the Ontario network held a summit to discuss strategy for enhancing the way we work together across the province to support persons with SCI/D beyond inpatient rehabilitation. Morning activities focused on reviewing important aspects of the Consortium such as the mission and objectives, current care gaps and the vision for the community. In the afternoon, we broke into 5 separate groups to plan implementation strategies for the routine 18-month follow-up that is to be put in place over the next year in partnership with SCI Ontario. Key Issues that were identified include the following:

- Opportunities or gaps in care that need to be addressed with the 18-month follow-up
- Structures and processes that should be in place to prepare patients for the 18month follow-up prior to discharge
- Elements of the referral system were identified that are done well as well as elements that are a challenge
- Perspectives from a lived experience viewpoint were shared







SCI IEQCC Summit HIGHLIGHTS DAY 2

On October 7, members of the network continued part 2 of the summit to discuss several things such as:

- Sharing the rationale for the 18-month follow up
- Collectively planning to facilitate routine referrals to patients with SCI Ontario
- Describing and monitoring PLEX at 18-months after rehab admission
- Enabling advocacy and policy change through network resources


Into the afternoon Ontario Consortium members continued the meeting with practical follow-up exercises, in which the IES's presented their site's answers to some practical case study scenarios to demonstrate the varying resources available to each site and how each site would handle the situation. Following the case studies, the planning of the 18-month follow-up implementation was presented to the group to provoke brainstorming within each individual on how to implement the follow-up at each site. This also helped to inform what type of resources might be a part of a toolkit that would be available to support patients identifying any issues during the follow up assessment.

SCIO's Vision for the partnership with Consortium:

We are excited to partner with all the specialized rehab centres across Ontario to develop a coordinated referral process that introduces SCI-O services to persons with spinal cord injuries sooner in their rehab journey. This will be an important part of providing a more collaborative and seamless transition back into the community no matter where one lives. Implementing this coordinated referral process with each rehab partner will lay the foundation that is needed for SCI-O to continue consortium activities including the post rehab 18-month follow-up in the community. A key part of this work will involve establishing agreements with each facility and designing a referral process that will allow SCI-O in partnership with the rehab sites to follow and provide support to individuals in their communities throughout the province.



At the Summit (see Pages 2-4), the key building blocks show to the left were developed. These provide the framework for the IES's to work collaboratively with SCI-O and the Central Consortium team to create the practice profiles and other components of a fulsome implementation plan. This work will unfold over the next 2 years with the Universal Referral system expected to be in place over the next calendar year followed by development of a Universal QI process that will meet the needs at each local site.

Wheelchair Skills Course

The Wheelchair Skills Program (WSP) is a free online high-impact, evidence-based resource for the assessment and training of the wheelchair skills of users. These include manual wheelchairs with or without the assistance of caregivers, powered wheelchairs and motorized mobility scooters.





Many of the Implementation & Evaluation Specialists and other clinicians within the Ontario rehabilitation sites completed a course last December about the WSP led by Dr. Lee Kirby from Dalhousie University.

This course has supported clinicians in delivering improved service to support patients and their caregivers (when needed) in using two-hand propulsion of manual wheelchairs. The course was conducted over 6 weeks in Oct-Dec and involved a final exam to test the knowledge retained by the participants.
